Below are the requirements for a regular license renewal.

The requirements do not apply to those who need post-licensing education, 45-hour post-licensing for first renewal of sales person license or 60-hour post-licensing for first renewal of a Broker license.

All real estate licensees in Florida renew on either March 31 or September 30.

14 Hours:

- 3 Hours Core Law (all Core Law classes at NABOR are 3 hours)
- 3 Hours Business Ethics (all Ethics classes at NABOR are 3 hours)
- 8 Hours Specialty (you can take multiple classes; they just need to add up to a minimum of 8 hours)
